Proposed Amendments to Placing Request Arrangements Summary Proposal Paper

South Ayrshire Council is consulting on proposed amendments to its Placing Request arrangements. The proposals include a change in the criteria for determining placing requests and to discontinue the involvement of the Local Attendance Council in the initial stages of the placing request process. The proposed changes will give some priority to children and young people resident within South Ayrshire.

The proposals do not seek to change the present catchment areas for the schools and children and young people within a catchment area will continue to be given priority in the allocation of spaces. The Council wish to seek views on the above proposal from all interested parties including parents/carers of children and young people attending South Ayrshire Schools and parents/carers of any child or young person who would be expected to attend a South Ayrshire School within the next two years.

The proposal requires statutory consultation under the Schools (Consultation) (Scotland) Act 2010 and full details of the proposals are available from South Ayrshire Council's website at <u>www.south-ayrshire.gov.uk/consultations</u>.
